Modifying financial costs in the Technical Regulations for Data Registration Procedures and Issuance of Energy Efficiency Label for Vehicles and Tires

The Saudi Standards, Metrology and Quality Organization announced amending the financial costs in the technical regulations for procedures of data registration and issuance of Energy Efficiency Label for vehicles and tires and the cost of Lighting products registration, including:

- Canceling the costs of reviewing the issuance of the Energy Efficiency Label of five hundred (500) riyals by deleting paragraph (C) of Article 9 of the technical regulation of the procedures for registering data and issuing the Energy Efficiency Label of in vehicles and tires.
- Modifying the costs decided in the Board of Directors of the Authority at its meeting No. (154) held on n item (2) regarding determining the value of registration costs for lighting products in the Authority, so that the value of registration costs for lighting products becomes a fixed amount of two thousand (2000) riyals for each model.

Launching the initiative “ Raising the efficiency of energy consumption for products “

SASO announced the adoption of the initiative “Raising the efficiency of energy consumption for products”, in cooperation with the Saudi Center for Energy Efficiency within the framework of the Saudi Program for Energy Efficiency in order to encourage the import and manufacture of high-efficiency models, by imposing an additional fee for issuing the energy efficiency labels for less efficient products.

Zakat, Tax and Customs Authority

Zakat, Tax and Customs Authority calls on importers to take advantage of the customs services available through their website

Zakat, Tax and Customs Authority called on importers to benefit from the customs services available through its website, which enables them to finish their customs procedures and obtain the service easily, and with easy and clear steps.

The Authority explained that one of the most prominent customs services provided through the Authority’s website is the postponement of the collection of customs duties, which allows the possibility of postponing it for 30 days from the date of the clearance process, so that importers can submit a request for postponement, by determining the appropriate path, whether the path of postponement by submitting the bank guarantee, or the path of postponement by submitting the documentary declaration, and added in this regard that it is required to meet all the requirements and criteria specified by the Authority to benefit from it, which can be seen when submitting the request through the Authority’s website.
