Tabseer Company participated in the meetings of the Gulf Cooperation Groups for the Accepted Bodies, during the period From 25-21 May 2023 AD, which the GCC Standardization Organization Arabia organized in Riyadh.

It discussed the activities of the meetings of the Gulf Cooperation Group for the bodies approved for the Technical Regulations of Gulf Low-Voltage Electrical Appliances and Equipment, Developments of the Conformity Certification System Gulf, and future directions to enhance the safety of low-voltage electrical products in the markets Gulf, in the presence of a large number of experts.



Declaration by tomorrow

SASO announced a new Circular of HS Codes and Products to be added to the Shipment Certificate

Saudi Standard, Metrology, and Quality Organization announced issuing a Circular obligating importers and manufacturers to fill out a declaration for limited products to which the industrial audit tool is applied. Indicated that in the published several circular products and HS codes have been added to the required declaration to be filled out when submitting Shipment Certificate requests through the Saber E-platform, starting from the 10th of this month. And these products include (Ceramic Tiles, Paints and varnishes, Carpets, and Rugs). Stressing that only one party is allowed to issue an approval for Shipment Certificate through the system from tomorrow if the form is approved by the Ministry of Industry and Mineral Resources as one of the technical file attachments.

It also pointed out that random samples will be drawn from the Shipment Certificate issued through the system and verification of the existence of the approved declaration, and the action will be taken, according to the situation, against any conformity assessment body that issued conformity certificates for products or Shipment Certificate in violation of this circular.
